## President's Comments: Ross H. Schwalm

On February 4 and 5, I attended the VASSAR Annual Meeting in Richmond, VA. I procured for the chapter the latest version of "Genealogical, Burial, and Service Data for Revolutionary War Patriots Buried in Virginia. This book is the second edition and there is also updates provided since printing. This book will be provided to the Compatriots who are selected as the Grave Marking and Grave Registration leaders.

I attended two workshops. The first was the VASSAR 250<sup>th</sup> Anniversary Committee. We were given information on the resources available from the NSSAR committee and on what plans are in the works within Virginia. When given the floor for comments, I indicated that Prince William County wants to build a memorial to the Virginia Continental and militia units from the county. I was given verbal comments from several Compatriots including the new State President that they want to help with this project.

The second workshop I attended was on Membership. State Vice President Ernie Coggins asked me to provide comments on how our chapter was able to grow. Registrar Mike Blyth provided me comments and I added others for my talk to the workshop. President Richard Rankin of the George Washington Chapter and Compatriot Dale Corey also provided comments which are closely related to what we do in our chapter. Membership is a top priority for the state this year. Look for more information as the State President has recently transmitted his plans for 2022-2023.

During the Annual Meeting during Chapter President Reports, I mentioned the County Memorial project. The chapter was given 4 ribbons which were presented to the chapter at the March meeting.

I attended the Youth Oratory Contest and heard three great speeches. While the judges were deliberating, VASSAR Eagle Scout of the Year sponsored by our chapter, Christina Alvarez, was given her Eagle Trophy. I was able to meet her and wished her well at the National Competition.

Compatriot Tim Cline (our Eagle Scout Award Coordinator), Vice President Leamon Duncan and I attended Troop 1919 Eagle Court of Honor on February 23. One of our own compatriots, Jacobi Henderson, was a recipient of an Eagle certificate and patch. I provided the attendees of around 60 people along with many more via Zoom from all over the country comments on the importance of service to the community, the state and the country. I related this to my service in the military and how this was taught to me by the many veterans in my family all the way back to the American Revolution. Several veterans approached me after the event to thank me for my reminder of service to these Eagle Scout leaders as well as to those in attendance.

I have officially retired from work on February 28 and hope to have more time in support of my three non-profit history and genealogy organizations.

The Prince William County Office of Historic Preservation hosted a panel discussion at the Tin Cannon Brewing Company in Gainesville, Virginia at 6:00 PM on March 2, 2022. Panelists included local historians who were asked various questions and provided responses from various perspectives as veterans and citizens of Prince William County. I participated as a panelist, along with historians William "Billy" Griffith, John N. McDonald and Kevin Pawlak, with Mr. Pawlak serving as moderator. The questions covered the French and Indian War, the American Revolution, the Civil War, World War I, World War II and the Persian Gulf War. I entertained the audience of 30 people with a photograph of my first visit to Prince William County Manassas Battlefield Park in 1973. I also provided a short-handled axe "liberated" from an Iraqi self-propelled 122millimeter howitzer during Desert Storm. Mr. McDonald displayed the collection of World War II uniforms he acquired while working as the lead historian at Rippon Lodge which was owned by a descendant of the Blackburn family who served in the US Navy during World War II. Significant discussion and questions by the audience revolved around the American Revolution in Prince William County. Many were unaware of this history which included the early days of forming militia and then Continental line units as well as Dumfries as a Hessian prisoner of war site in 1777. I also covered the Marine Corps history in the county. These events are free to the public and the owners of Tin Cannon Brewing Company were pleased with the turnout and the history offered. The panel discussion ended at 8:00 PM and informal discussions continued well into the night until closing time.

I participated in the Battle of Great Bridge Tour offered by American History LLC on March 18, 2022. The tour was sold out at 44 people and the tour guide was SAR Norfolk Chapter Compatriot Pat Hannum, Lt. Col USMC Retired. The tour mustered at Woodlands Resort in Williamsburg and Mr. Hannum narrated a prelude to the battle on the way to the tour's first stop at the St. Paul's Episcopal Church in Norfolk. Here we learned how the city was shelled by the British Navy in retaliation of Virginia and North Carolina troops firing on British ships in the Elizabeth River. The shelling made the town unlivable for civilians including loyalists to the Crown, those in support of the Revolution and those neutral to either side. The Virginia and North Carolina troops added to the misery by burning down other structures so the British would not be able to use the city as a staging area. This action in southern Norfolk was the last part of the campaign to evict Lord Dunmore from Virginia. The next stop was Kemp's Landing which was the location of the first engagement in the campaign. The British troops chased the Virginia militia away from Kemp's Landing with one volley. The last stop on the tour was the Great Bridge Museum and Battle Site. The tour group was split into four groups and docents conducted detailed briefings while walking around the battle site area. The tour included a visit to the Great Bridge Museum which was very educational.

Compatriot Keith Rouleau and I attended the 9th American Revolution Conference organized by American History LLC in Williamsburg, VA. We met other SAR members from Georgia, Alabama, and Virginia. The conference leader was Bruce Venter who opened the conference with introductions of those who donated funding and books to the book sale. His comments included a by name mention of Ross H. Schwalm as President of the Johannes Schwalm Historical Association and as President of the Col. William Grayson Chapter of the SAR. This led to many attendees and speakers introducing themselves to me which allowed me to talk about both JSHA and SAR activities. A notable attendee was Rob Orrison of the Office of Historic Preservation for Prince William County. James Kirby Martin opened the conference with a briefing related to how the historiography of the American Revolution has changed over the last two centuries. He made the case that much of what is being written now is not supported by the primary sources and therefore has no place in the body of knowledge of the Revolution. He encouraged all to go back to the primary source original documents to make your case in support of your hypothesis. Sometimes, the evidence is just not there. He left academia and is now free to tell the truth vice a list of facts and myths to be memorized as gospel. Eric Schnitzer, National Park Service Historian at Saratoga Battlefield Park gave his myth buster briefing of the truth behind what really happened at the Saratoga battle which is not what has been taught for decades even by the signage and markers currently in use. The rest of the conference speakers essentially laid out the same unofficial theme of "Context, Context," and sorted out good creative non-fiction writing from story-telling which is often not supported by original source documents. The last professional historian and professor, Dr. Michael Gabriel, Kutztown University and JSHA Director, gave a presentation on plunder, the legal basis of plundering, and the economics of the system of selling plunder to fund the Continental Army needs and to reward the officers and men who helped capture the plunder in the first place. He admitted several times that the records are not sufficient to get an exact accounting of how much the plunder system generated for the units and governments involved in receiving the benefits.

I attended the Prince William County American Revolution Memorial Planning Meeting on March 23, 2022, along with Compatriot Dave Button. We met with Prince William County Office of Historic Preservation Division Manager Robert Orrison at William's Ordinary. We discussed the memorial actions to date and some of the next tasks in the project. First topic was a quick review of locations. We developed an analysis matrix to define the advantages and disadvantages of each site for the memorial as well as a priority for each site to help determine a path forward. The matrix refinement was given to me for action. As we collect information, we can build out the information in the matrix. Mr. Button took the task to visit with Kline Memorials in Manassas to get a rough order of magnitude dollar figure on an obelisk type monument. Mr. Orrison took the task to engage with the Dumfries Town Manager and the Dumfries Mayor to gauge their level of support to the project. There is immediate and mid-range changes that are happening in Dumfries that forces the memorial committee to speed up its recruitment of volunteers and support from SAR, DAR, and other strategic partners. We have a draft Memorial Committee Structure which includes an Incubator Committee for ideas for consideration, an Executive Committee of senior leaders from the county and towns of Dumfries and potentially Woodbridge, a Land Acquisition sub-committee, a Design sub-committee, a Planning, Budgeting and Financial Management sub-committee, a History sub-committee, a Fund Raising sub-committee and a Communications sub-committee.

The second topic of discussion was follow-on actions necessary from the Colonel William Grayson Vigil. Mr. Orrison shared the county's report on the tomb repairs done in 2014. He is gathering estimates on fixing the current crack in the tomb. I was tasked with contacting Good Shepard Housing Foundation about replacing the

flag at the tomb site. This was done on March 23, and we are awaiting further information as the two Foundation points of contact are both on vacation. We intend to retire the current flag as part of the flag replacement. This will be a SAR and DAR event.

The third topic of discussion was the upcoming meeting on March 31, 2022, at 6:30 p.m. to discuss options for the future of William's Ordinary. I was invited to participate in this discussion and will attend the meeting. I proposed that William's Ordinary set aside space to have an America250 information desk for the county. The vision is to have the Chapter Flag and our 250th Flag on display and have volunteers from SAR, DAR, and others support the county in manning this desk. The county no longer has a tourism or visitors bureau. Mr. Orrison has requested two new employees for the Office of Historic Preservation to focus on marketing and providing tours of the various history sites in the county. I was asked to brief this idea at the March 31 meeting.

I attended a virtual event entitled a "Community Conversation on Building Community through Historic Preservation" sponsored by America250. This event provided ideas on how to engage the community in order to preserve historic places, structures and even paper reports/photographs/artifacts via digitization. Prince William County Office of Historic Preservation is engaging the community on what should be preserved and what should be remembered with many different programs. The Chapter has been included in building a monument to the soldiers and militiamen who served the cause of the American Revolution. Additionally, I will be serving on a new committee to generate ideas and actions to preserve the historic building known as William's Ordinary. Significant modern creep is happening in Dumfries, Virginia that could doom the historic roads and buildings if actions are not taken. This thought was part of the discussion virtual event. Chapter compatriots are encouraged to visit www.america250.org for additional information about America250.

Compatriots Dave Button and I attended Jim Piecuch's lecture on "Light Horse Harry Lee in the War for Independence" on March 24, 2022, at 7:00 p.m. The event at the Old Manassas Courthouse, sponsored by the Prince William County Historic Preservation Division was well attended. The lecture was a summary of Lee's life. Highlights includes some of Lee's famous and infamous events.

I attended a veteran's breakfast at Jubilation in Fredericksburg, Virginia. Jubilation is an over 55 community and hosts this breakfast as an outreach to veterans. The event was organized by Marine Corps Veteran Tom Dempsey who is a resident of Jubilation. His son, Marine Corps Major Brian Dempsey provided the lecture on his assignment at Quantico as the Unmanned Aerial Vehicle (UAV) Capability Officer. His lecture included videos from several operations showing the capabilities that UAVs bring to the warfighters. He had models of several different type 1 small UAVs. After the lecture, the attendees were treated to a flying demonstration on the grounds of Jubilation to show real time video capabilities of a small inexpensive UAV. Over 20 veterans attended the breakfast along with representatives from Jubilation who were available to provide information on the facility and to give tours. This breakfast is a monthly event free to veterans.

On March 27, I delivered remarks at the National Vietnam Veterans Day Remembrance on Sunday, March 27, 2022 at the Historic Fairfax Courthouse Memorial Plaza in Fairfax, Virginia, which you can read here:

Chaplain (Colonel) Morgan is assigned on the Headquarters Department of the Army staff. The ceremony was held at the historic Pohick Church in Lorton, Virginia. Pohick was the first permanent church in the colony to be established north of the Occoquan River, sometime prior to 1724 and is where George Washington frequently attended services. The presiding officer over the ceremony was Chaplain (Major General) Thomas L. Solhjem, 25<sup>th</sup> Chief of Chaplains, United States Army.

Members of the Virginia SAR came from across Virginia to support the ceremony. SAR support to the ceremony aligns with one of the National Society's Patriotic Goals to support our Veterans who sacrifice so much in the service to our great Nation. SAR support for the event was organized and led by Leamon Duncan, Colonel William Grayson Chapter. Supporting elements included Mike Weyler, Colonel William Grayson; William (Bill) Schwetke, Culpeper Minutemen; Dale Corey, Allan Phillips, and Chip Daniels, Colonel James Wood II; and David Cook and Forrest Crain, Fairfax Resolves. #### William "Billy" Lee NSSAR Patriot P-234885

William "Billy" Lee was born around 1752 in Westmoreland County, Virginia and was purchased in 1768 by General Washington. He accompanied General Washington as his valet, or "Val de Chambre" in many of his engagements during the American Revolution, including the Battle of Monmouth and at the surrender at Yorktown. He later accompanied then President Washington to the first capital in New York City. He married Margaret Thomas in the early 1780s. Upon Washington's death in 1799, he was freed and remained on the Mount Vernon estate. He died here in 1828 and is buried in the Slave Burial Ground.

## Historical Notes: The Prayer at Valley Forge



The Prayer at Valley Forge

Arnold Friberg painted "The Prayer at Valley Forge" in 1975 in time for the Bicentennial of American Independence. The painting has become a modern icon. Friberg visited Valley Forge during the winter to immerse himself in the conditions faced by Washington and the American patriots.

The original story of Washington kneeling in prayer at Valley Forge may be apocryphal, having originated with an account by Reverend Nathaniel Snowden which began to circulate in the early 1820s. Reverend Snowden recounted that one of Washington's soldiers, a man named Isaac Potts testified to him:

"I tied my horse to a sapling and went quietly into the woods and to my astonishment I saw the great George Washington on his knees alone, with his sword on one side and his cocked hat on the other. He was at Prayer to the God of the Armies, beseeching to interpose with his Divine aid, as it was ye Crisis, and the cause of the country, of humanity and of the world.

"Such a prayer I never heard from the lips of man. I left him alone praying. I went home and told my wife. I saw a sight and heard today what I never saw or heard before, and just related to her what I had seen and heard and observed. We never thought a man could be a soldier and a Christian, but if there is one in the world, it is Washington. She also was astonished. We thought it was the cause of God, and America could prevail."

Many historians question Reverend Snowden's story, if not that Washington was a man who prayed. There are numerous examples of Washington invoking the blessings and protection of the Almighty, including at the time of his leaving the Army:

"I consider it an indispensable duty to close this last solemn act of my Official life, by commending the Interests of our dearest Country to the protection of Almighty God, and those who have the superintendence of them, to his holy keeping."
