President's Comments: Michael Wilson

Since our last meeting I have had the pleasure of representing our chapter at several state and national SAR events, Virginia Society Children of the American Revolution events, Patriotic-heraldic society event, and an Honor Flight event. As I travelled over the great commonwealth of Virginia, the three most remarkable events I have had the pleasure in attending were: (1) the first Patriot Burial Roadside Maker dedication for a Revolutionary War Patriot and U.S. Congressman, (2) National Society Sons of the American Revolution Gold Good Citizen Medal presentation to Mr. Freedom by NSSAR President General, John Dodd, and (3) the Honor Flight – Top of Virginia Mission #20.

The Virginia Society Sons of the American Revolution, along with the Richmond Chapter, honored Revolutionary War Patriot Major Joseph Eggleston, who served in Lighthorse Harry Lee's Legion, by placing the first 'Patriot Burials marker' in partnership with the Pomeroy Foundation, on Sunday, November 05, 2024. This was one of three Patriot Burial markers to be placed within the Commonwealth of Virginia. The Pomeroy Foundation Patriot Burials Marker Grant Program was established to assist SAR state societies and is a national marker program to commemorate historical points of significant interest in the Revolutionary War period while recognizing those Patriots who fought in or contributed to America's independence.

Meeting and speaking with Enes Kanter Freedom, a former player for the Boston Celtics (2022) honored with a NSSAR Gold Good Citizen Certificate and Medal on Sunday, May 26, 2024 (Gunston Hall, Lorton, VA by PG Dodd) for his acts of heroism during his time in the NBA and his charitable endeavors off the court, was incredible and a true honor. PG Dodd said it best, "[Mr. Freedom] is a thoughtful and gracious man. Just as our Patriot Ancestors pledged their 'lives, fortunes and sacred honor' in the Declaration of Independence, so too, Mr. Freedom has sacrificed much for his principles. We are lucky to have him as a Naturalized Citizen...". Mr. Freedom, with a warm smile and gentle handshake, graciously shared his childhood stories and patriotic

pride with the attending audience and showed why he was selected and so deserving of such high honors by our national society.

In closing, the Colonel William Grayson Chapter Annual 2025 Officer elections are around the corner. Any compatriots interested in *Chapter Presidency* or various officer positions within the chapter should email myself or chapter secretary, Dave Button. Nominations will be finalized and presented at the October 12th meeting held at the Veterans of Foreign Wars (VFW) 7589, Manassas, VA.

Vice President's Report: Andrew Mills

There are times during the calendar year where we feel overwhelmed by the number of events the SAR hosts. The adage of "so much to do, so little time" fits in very well here. Between Memorial Day weekend and Flag Day, there are numerous events which can take us across the region. However, this year there were a handful of events which held significant meaning to me.

The first event was an annual tradition my family started in 2020 after joining the SAR. Over the Memorial Day weekend, we go to the Dumfries Cemetery and place flags at the graves of the Patriots buried there. To date, we can identify 15 of the 20 graves at the cemetery and place flags there. Through this tradition, we have noticed other people have begun to mark the Patriot graves as well on Memorial Day. It is truly heart-warming to know our small contribution has led to others in our community to follow this example and remember the service of the first Patriots.

The second event was the Gold Citizenship Award Ceremony at Gunston Hall. For those in attendance, we had the privilege of meeting Ennes Kantor Freedom, a former NBA basketball player who is a human rights activist. While many celebrities and athletes claim to do things, Mr. Freedom (who legally changed his last name to Freedom) puts his money where his mouth is. For those who do not know, there is a bounty on him from the Turkish government because he shed light on human rights violations occurring within his home country. In addition, he was black balled by the NBA for speaking out against China and the human rights abuses there. When asked what message he would give to young people about how they should live their lives to counter the materialistic message being sent out daily, he responded, "Faith, family, and Freedom. These are the three most important parts of our lives. Without these, you cannot be happy." This is significant to us in the SAR, as it was faith, family, and freedom which were at the core of many Patriots reasons for fighting.

The third event was the unveiling of the Prince William Resolves plaque in Dumfries. Joined by Ken Morris and Ross Schwalm, we represented VASSAR amongst so many other local dignitaries. It was interesting to learn the history of the Resolves as Prince William County was the first to issue these Resolves and everyone else in the state followed our example. Despite Fairfax County being better known for their Resolves, we can take heart in knowing Prince William's was first. Huzzah!

Finally, there was the Commemoration of the Virginia Declaration of Rights. It can never be overstated how important this document was, as it served as the blueprint for the Declaration of Independence. However, as this Commemoration was occurring, the naturalization of new citizens was also occurring at Gunston Hall. Some of these new citizens come to witness our event, but what is more significant is that we see in them the heart of the Revolution.

Our Patriot ancestors fought not only for freedom and liberty for themselves, but for those yet to come. It was because of their courage and sacrifice we have our nation today. So let us look at our events and try to remember the meaning behind them. It is not just for commemorations, but a chance for us to reflect upon why our ancestors chose to fight, the forces which gave them the strength and conviction to see the conflict through to the end, the results of their successes, and an opportunity to honor their legacy.

Registrar's Report: Mike Blythe

We have had one new member approved and registered this quarter. Jerry Maynard Couretas of McLean is a descendant of Patriot Isaiah Maynard who served as a Member of the Committee of Safety for Westchester County, New York in 1776-1777. He is also recognized for selling beef to the Army in 1777. In the American Revolution, local committees, sometimes called committees of correspondence, committees of inspection, committees of observation or committees of safety, were different resident groups of Patriots that became a shadow government; they took control of the Thirteen Colonies away from royal officials, who became increasingly helpless as the war drug on. The historian, T. H. Breen, writes that "proliferation of local committees represented a development of paramount importance in the achievement of independence," because the committees were the first step in the creation of "a formal structure capable not only of policing the revolution on the ground but also of solidifying ties with other communities." The network of committees was also vital for reinforcing "a shared sense of purpose," speaking to "an imagined collectivity—a country of the mind" of Americans. They led to popular politics in America – ordinary people would no longer trust a body of just wealthy, educated men to lead them.

As of 14 June our chapter has 9 new member applications pending review at State or National. The process is taking longer as we enter the summer months. An application will generally spend two months at State – the State Registrar has applications from 30 chapters to review – and another three months at National before it is reviewed.

Please consider submitting a supplemental application. Our desire is to document as many lines to the Patriots as possible. The current application fees are \$100 (NSSAR), \$12 (VASSAR), and \$15 (CWGC).

Finally, if reelected, 2025 will be my last year as the chapter's Registrar. If you have an interest in genealogy and would be interested in becoming the Registrar, let me know so that we can start working together on future applications (mblythe@comcast.net).

Historical Notes:



George Mason

The Fifth Virginia Convention met in Williamsburg on May 6, 1776. There were three power groups represented at the Fifth Convention. The more conservative group represented the wealthy planters. The second group was made up of the political philosophers, George Mason, George Wythe, Thomas Jefferson and James Madison. The third group was a mainly from western Virginia and included radicals, such as Patrick Henry, who had supported independence earlier than 1775.

On May 15, the Convention declared that the government of Virginia as "formerly exercised" by King George in Parliament was "totally dissolved." On June 7, Richard Henry Lee, one of Virginia's delegates to the Continental Congress, following the instructions of the Virginia Convention, proposed that "these United Colonies are, and of right ought to be, free and independent States, that they are absolved from all allegiance to the British crown, and that all political connection between them and the State of Great Britain is, and ought to be totally dissolved." While the Continental Congress debated Richard Henry Lee's proposal, the Virginia Convention adopted George Mason's "Virginia Declaration of Rights"

A DECLARATION OF RIGHTS made by the representatives of the good people of Virginia, assembled in full and free convention which rights do pertain to them and their posterity, as the basis and foundation of government.

Section 1. That all men are by nature equally free and independent and have certain inherent rights, of which, when they enter into a state of society, they cannot, by any compact, deprive or divest their posterity; namely, the enjoyment of life and liberty, with the means of acquiring and possessing property, and pursuing and obtaining happiness and safety.

Section 2. That all power is vested in, and consequently derived from, the people; that magistrates are their trustees and servants and at all times amenable to them.

Section 3. That government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety and is most effectually secured against the danger of maladministration. And that, when any government shall be found inadequate or contrary to these purposes, a majority of the community has an indubitable, inalienable, and indefeasible right to reform, alter, or abolish it, in such manner as shall be judged most conducive to the public weal.

Section 4. None of mankind is entitled to exclusive or separate emoluments or privileges from the community, but in consideration of public services; which, not being descendible, neither ought the offices of magistrate, legislator, or judge to be hereditary.

Section 5. That the legislative and executive powers of the state should be separate and distinct from the judiciary; and that the members of the two first may be restrained from oppression, by feeling and participating the burdens of the people, they should, at fixed periods, be reduced to a private station, return into that body from which they were originally taken, and the vacancies be supplied by frequent, certain, and regular elections, in which all, or any part, of the former members, to be again eligible, or ineligible, as the laws shall direct.

Section 6. That elections of members to serve as representatives of the people, in assembly ought to be free; and that all men, having sufficient evidence of permanent common interest with, and attachment to, the community, have the right of suffrage and cannot be taxed or deprived of their property for public uses without their own consent or that of their representatives so elected, nor bound by any law to which they have not, in like manner, assented for the public good.

Section 7. That all power of suspending laws, or the execution of laws, by any authority, without consent of the representatives of the people, is injurious to their rights and ought not to be exercised.

Section 8. That in all capital or criminal prosecutions a man has a right to demand the cause and nature of his accusation, to be confronted with the accusers and witnesses, to call for evidence in his favor, and to a speedy trial by an impartial jury of twelve men of his vicinage, without whose unanimous consent he cannot be found guilty; nor can he be compelled to give evidence against himself; that no man be deprived of his liberty except by the law of the land or the judgment of his peers.

Section 9. That excessive bail ought not to be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

Section 10. That general warrants, whereby an officer or messenger may be commanded to search suspected places without evidence of a fact committed, or to seize any person or persons not named, or whose offense is not particularly described and supported by evidence, are grievous and oppressive and ought not to be granted.

Section 11. That in controversies respecting property, and in suits between man and man, the ancient trial by jury is preferable to any other and ought to be held sacred.

Section 12. That the freedom of the press is one of the great bulwarks of liberty, and can never be restrained but by despotic governments.

Section 13. That a well-regulated militia, composed of the body of the people, trained to arms, is the proper, natural, and safe defense of a free state; that standing armies, in time of peace, should be avoided as dangerous to liberty; and that in all cases the military should be under strict subordination to, and governed by, the civil power.

Section 14. That the people have a right to uniform government; and, therefore, that no government separate from or independent of the government of Virginia ought to be erected or established within the limits thereof.

Section 15. That no free government, or the blessings of liberty, can be preserved to any people but by a firm adherence to justice, moderation, temperance, frugality, and virtue and by frequent recurrence to fundamental principles.

Section 16. That religion, or the duty which we owe to our Creator, and the manner of discharging it, can be directed only by reason and conviction, not by force or violence; and therefore all men are equally entitled to the free exercise of religion, according to the dictates of conscience; and that it is the mutual duty of all to practice Christian forbearance, love, and charity toward each other.
